Albuquerque, NM - Attorney General Hector Balderas and UNM President Garnett Stokes, after meeting earlier this week, have declared a shared commitment to actively looking for ways to positively change the way the two organizations work together in service to the University community and the citizens of New Mexico.

"I am optimistic that UNM, under President Stokes' leadership, will be held accountable for improving cooperation and creating greater efficiencies in the interest of serving justice and being open and transparent," said Attorney General Balderas.
